RESOLUTION NO. TC 2016-20

A RESOLUTION OF THE NEW CASTLE TOWN COUNCIL RATIFYING VARIOUS INTERGOVERNMENTAL AGREEMENTS HERETOFORE APPROVED BY TOWN COUNCIL.

WHEREAS, Section XIV of the Charter of the Town of New Castle (“Town”) authorizes the Town Council to enter into intergovernmental contracts or agreements (“IGAs”) for the use of buildings, equipment, or facilities; for furnishing or receiving commodities or services; and for other matters in the best interests of the Town; and

WHEREAS, the Charter provides that such agreements must be approved or authorized by resolution or ordinance adopted by the Town Council;

WHEREAS, prior to the date of this Resolution No. 2016-20, the Town has entered into those certain IGAs listed on **Exhibit A** attached hereto that were approved by motion or otherwise at duly-noticed public meetings of the Town Council; and

WHEREAS, the Town Council hereby finds that said IGAs were of the type provided for in Section XIV of the Town Charter; and

WHEREAS, the Town Council now desires to ratify the IGAs listed on Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE NEW CASTLE TOWN COUNCIL:

1. Recitals. The foregoing recitals are incorporated by reference as findings and determinations of the Council.
2. Ratification. Pursuant to Section XIV of the Town Charter, all of the IGAs listed on Exhibit A to this Resolution are hereby ratified and affirmed.
3. Effect of Resolution. Nothing herein shall be construed to invalidate any IGA previously approved by the Town regardless of the method by which it was approved.
