

**TOWN OF NEW CASTLE, COLORADO  
ORDINANCE NO. 2018-3**

**An Ordinance of the Town of New Castle, Colorado summarizing additional expenditures for the Conservation Trust Fund and adopting a supplemental budget for the Town of New Castle, Colorado, for the calendar year beginning on the first day of January, 2017 and ending on the last day of December, 2017.**

WHEREAS, on December 6, 2016, the Town Council of the Town of New Castle adopted Resolution No. TC-2016-23, approving a budget for the calendar year beginning on the first day of January, 2017, and ending on the last day of December, 2017; and

WHEREAS, pursuant to the Home Rule Charter of the Town of New Castle, the Town Administrator has certified that during 2017, existing fund balances were available for appropriation in excess of those estimated in the 2017 budget, as indicated on Exhibit A attached to and incorporated by reference into this ordinance; and

WHEREAS, the Town Administrator and the Town Finance Director/Treasurer have prepared and submitted a proposed supplemental budget for the 2017 calendar year to the Council for its consideration; and

WHEREAS, on May 15, 2018, the Council held a public hearing on the proposed supplemental budget, after publication in accordance with the Charter of notice of such public hearing and notice that the proposed budget was on file for public inspection in the office of the Town Clerk; and

WHEREAS, after the public hearing, the Council gave due consideration to the input of the public and any issues raised at the hearing; and

WHEREAS, the Council desires to adopt the supplemental budget, as amended in accordance with discussion at the public hearing; and

WHEREAS, whatever increases may have been made in the expenditures, existing, unappropriated fund balances were available so that the budget remains in balance as required by law.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF NEW CASTLE, COLORADO THAT:**

1. The Town Council incorporates the foregoing recitals as findings of fact and determinations by the Town Council.

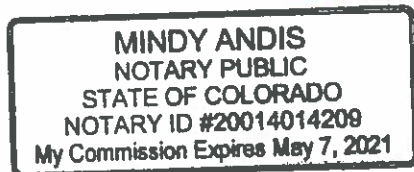

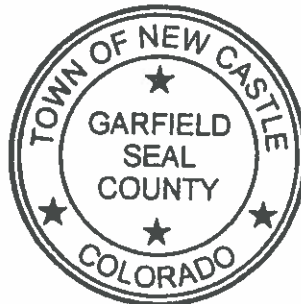
